#2 - Temp on inside needs to be between 50 + 85

#7 - Chainlink on primary enclosures (inside runs) where it has been repaired so many times needs to be replaced with new chainlink. (Dangerous to animals)

#9 - Temp. in AREA where primary enclosures ARE needs to be 50 + 85 AT ALL TIMES. 40° AT time of inspection

#11 - Large build-up of waste in outdoor runs/ needs to be cleaned daily. (2 times)

#14 - Floors + chainlink on inside needs to be free of hair build-up and debris.

#25 - Shot records on All Animals need to be in the Facility not just wrote down on kennel cards.

wooden dog doors need to be replaced with material impervious to moisture.
