



Primary Enclosures 0204 - 1st k-9 room on left - 5th & 7th runs have rusted fence pipes that need to be replaced, outside kennels - # 11 - broken gate pole, # 10 & # 9 broken pipes. Replace / repair the identified rusted or broken pipes / poles. Kennels were clean and odor free, records in order. Temperatures were in range in all areas.
