Starting with green wing of facility-flaps on guiletine doors need to be replaced, ceiling in this wing needs to be replaced, frames around outdoor runs are rusted as well as bottom rails on 1,4,6,7,8,14 and 17and need to be replaced. gravel needs to be added in play yard as well as bare dirt areas in large play yards.Wood dog houses and wood climbing posts need to be removed.Wood post on shed in gravel yard need to be covered. Wood shed in grass yard needs to be removed. Continue to reseal/repaint cracks in concrete. Repaint/seal fence in gravel yard.
