3) A sufficient amount of gravel has been added to the primary enclosures.

4) Improved roofing has been implemented which directs rainwater away from the primary enclosures.

5) Food bowls were protected under new roofing.

Inadequacies noted at today's inspection include:

1) Although some damaged dog houses have been replaced several still exist. Repair/Replace damaged dog housing. (0207).

2) Several water buckets have been chewed and are now damaged. Replace/Repair damaged buckets. (0206).

3) Anytime a new animal is introduced to an enclosure at this facility all waste and debris must be removed from that enclosure and all accessories (such as food/water receptacles, housing, blankets/bedding, etc) must be removed from that enclosure and sanitized prior to the introduction of such animal(s). (0207)

Records were available on all animals requested. No sign of illness/injury in the general population.
