Narrative Explanation

Random inspection performed today after receiving an e-mail stating that the staff were housing cats in metal traps, for the duration of their stay at the shelter. Facility is in the process of being cleaned while I'm present. With no apparent signs of disease or illness noted.

I did view all intake and disposition records for all animals since July 2014. All required records are on site and within AWA Regulations. Tips given to employees today on records keeping included: to attach owner surrender form to the intake records, and to add a block beside the intake date on the intake log, with an exit date and disposition.

0203} Outdoor drainage: It is noted at this inspection that the new enclosures at the back of the facility need a drain added to the front for removing waste, tip was to add a PVC pipe sawed in half with drain holes added along the bottom. This will catch the solid waste and allow the liquid waste to drain property.

No other inadequacies noted.
