- .0201 Facilities / Sound Repair - Front door of the facility - Metal door is rusted - either sand & re paint or replace this door.
- .0204 Primary Enclosures / Sound Repair - Outdoor exercise runs - Gates #'s left 1,2,3 and right #3 - all of these gates have rusted out areas that may be repaired by cutting the rusted pole and using an elbow. Owner needs to be aware all 6 chain link pens are showing age - rust. Follow up inspection in 60 calendar days - 11/10/14.
