Narrative Explanation, if needed

Item to address: .0201 Facilities / Housing (Building) in Sound Repair - The wood door between the canine & feline quarantine rooms is damaged. Either replace the door or repair the damaged area and reseal the door.

Comments: Since the last inspection an outdoor exercise yard has been created, a spay / neuter program has been started, a veterinarian comes to the shelter twice weekly to monitor the health of the animals. At present, county maintenance is on site. More ventilation is being created for the canine kennel room and all low burning or non burning lights are being replaced. The shelter is continuing to use a pest control company on a regular basis for insect control. Remember to keep all open boxes of treats in a closed container and keep feed storage building clean of any spilled food. follow-up on item .0201 in 30 calendar days.
