Narrative Explanation, if needed

New owner at facility, took over in September. Facility is clean and odor free and ambient temperature is 70 degrees. Judy has begun cleaning out and remodeling. Inadequacies are as follows: (0204) reseal/repaint cracks in floors of inside kennels. Remove/replace plastic flaps in kennels going to outside. Recaulk pavers in outside kennels and fill in any holes/cracks. Replace rusted metal flashing on edges of kennels. Repaint kennel doors as needed. Replace fluorescent light bulbs/ballasters to provide adequate lighting. Gave Judy an example of a sign in/sign out sheet that is required. Previous records are intact. Will reinspect in 30 days to check progress.. Ok to issue new license.
