	Purpose of visit today is due to complaint received from AWS office.	
	Items addressed since last inspection are as follows: - No longer mixing Clorox & Ajax. No animals had signs of URI today, no heavy fumes or chemical smell today - No rodents or rodent droppings observed today. - manager has utilized some of their older pens in Quarantine area. Now every animal is moved to a new, cleaned, sanitized pen daily. Shelter workers no longer clean with animals in cages.	
	Items that need to be addressed:	
<u>#2</u>	Some of the front cages in dog area do not have as much lighting as other areas making it difficult to view these areas. More lighting is needed in this area.	
<u>#13</u>	Multiple cracks noted in concrete floors. advised manager they needed to be sealed.	
<u>#15</u>	Plastic containers used for food & water need to be replaced as they become damaged from animal's chewing on them.
