



Narrative Explanation, if needed

New inspection performed as this facility closed in September and has now reopened with the previous owners. At the time of inspection I found that there were open bags of food in the facility. (0201) All food and treats must be stored in sealed containers. (0204) Wooden doors on cat enclosures must be covered or replaced with material impervious to moisture on the inside of the doors. (0102) Records were not readily available for "Shaq". There was no contract/boarding agreement signed. Vet records were verified at time of inspection via phone conversation. Records were current on the other 3 boarders. Husbandry was lacking as the floors appeared to have not been cleaned since previous dogs had left and there was hair/debris buildup on the kennel doors. Cleaning should be done a daily basis.

Narrative Explanation, continued

Damaged board on the front of Kennel E needs to be removed or an additional board needs to be added to back side so that the dog does not have access to the bare wood. Outside play yard will need to be reseeded in areas that grass is not coming back in and will need to be fenced off until growth is established. Overall the kennels were still in sound repair, temperature was in ambient range, and the turf in outside play yard was still in good condition.

License is pending approval once the above inadequacies are addressed. I will return in a week to follow up.
