Narrative Explanation

Follow up inspection performed. All walls are complete and have been painted with a second coat. The paint has began to chip on the back walls in a few kennels and this will be touched up this week. Walls have stopped cross contamination and has helped decrease illness/disease in the general population.

Cat room is complete and is being implemented. Room is adequately ventilated therefore there is no odor. Illness/death seen in cats at the shelter has decreased. During the month of May there were 9 cats found deceased at the shelter. Of these 9, 2 were born at the shelter (neonates), 2 were strays, and 5 were brought in to the shelter in traps. I have suggested that Clai set a date and have all cat traps, transport boxes and crates brought into the shelter to be cleaned and disinfected all at one time in case disease being spread through the use of these items. These items are cleaned between animals but this will allow a fresh start with all of them knowing that all are accounted for and disinfected at one time.

There is an ongoing issue with cats injuring their paws in the kennel runs. We discussed having maintenance wrap the top of the chain length gates with metal fascia to cover the exposed cut chain length to see if this stops this injury from occurring.

Overall the shelter was well maintained and all animals were properly cared for. Records were intact.
