Narrative Explanation

Annual inspection performed today. Cleanliness was great. Kennel area had just been cleaned and no odor was detected. All animals appeared healthy.

- (0204) Stainless steel bank cages are used for cat enclosures. There is newspaper covering the bottom of the cages at this time. If there are 2 or more cats in a cage there must be a solid raised resting surface in the cage (which can be easily accomplished by an overturned plastic litter box).

- (0204) New paint is still chipping in the dog kennels. Gary stated that he still needs to contact Sherwin Williams to come out to see the problem while its still under warranty (already repainted once in the last year).

- In reference to the new S626 rules, officers had been verbally asking if animal had bitten in the last 10 days. I explained to Gary this has to be stated in writing and signed by the person releasing the dog/cat. He agreed to have the statement added to his paperwork for the person to sign.

- Photographic identification number must be added to paperwork when animal is released if not making a copy of the picture. We determined there is an existing field in their program to enter this number.

No other inadequacies noted. Great job overall!
