Documents Required to be Posted in Inspected Establishments and Custom Exempt Facilities

I. Purpose:

This document provides instructions for inspection personnel regarding documents required to be posted inside inspected establishments and custom exempt facilities.

IV. Procedure:

The following chart should be used by MPID personnel to determine what documents are required to be posted in State-inspected establishments, Talmadge-Aiken-inspected establishments, and Custom Exempt Facilities. The USDA "And Justice For All" poster must be displayed in a location visible to establishment employees. All other documents should be displayed in the office of the Inspector-in-Charge. In offices with limited space, a clip board may be used to display multiple documents.

NOTE: The USDA "And Justice for All" poster for TA-inspected establishments is different from the one for State-inspected establishments and Custom Exempt facilities. Please refer to the codes when selecting the correct poster.
