This assistance package is designed to help municipalities that have not met all the Tree City USA standards complete select urban forestry practices and community forestry activities that are foundational in the management of public trees and to achieve Tree City USA designation.

 - Municipalities and tribal governments that do not meet the standards for Tree
 City USA recognition
- Application period
 - The application period opens Jan. 1, 2026, and closes March 1, 2026.
- ▶ Project practices/activities/deliverables A qualified service provider will guide you in the completion of the following practices and activities. The N.C. Forest Service (NCFS) Urban and Community Forestry (U&CF) program will secure the service provider or assist you in securing a qualified service provider(s). Specifications and guidance documents for your review can be found on our <u>U&CF Resources and Specifications webpage</u> under the urban forestry section. The following are the practices/activities/deliverables that will be completed.
 - Sample tree inventory a statistical sample inventory of public trees utilizing iTree protocols and the NCFS U&CF sample tree inventory specification.
 - Management plan a management plan that includes analysis and outcomes as detailed in the NCFS U&CF management plan template focusing on public tree management.
 - Trees & Storms readiness plan Using the NCFS U&CF Readiness BMP, develop a Trees & Storms readiness plan.
 - o Public tree ordinance -- Review and update if necessary or develop.
 - Urban forestry standards & specifications Review and update if necessary or develop.
 - Outreach -- Product(s) and/or event(s) that engage, educate and inform the public about the project.
 - Arbor Day celebration
 - Tree planting -- design and completion of a "small" tree planting project (10, two-to-three-inch caliper trees) to celebrate the project.
 - Use of the NCFS U&CF tree supply and planting specification or approved equivalent is required.
 - Tree species to be planted must be on the NCFS urban tree list.
 - Two years of post-planting monitoring and watering are required.
 - Practice plan A plan detailing the location, tree species to be planted and post-planting care are required. Tree planting site and tree species selection must meet tree planting best management practices as defined

- by the NCFS U&CF Urban Forestation and Tree Planting webpage, specifications and guidance documents.
- Tree delivery supply, and planting inspections and reports completed by a qualified urban forestry professional are required.
- Supervision of the tree maintenance and/or tree planting work by an urban forestry professional is required.
- Final report a professionally published two-to-eight-page infographic-style report summarizing and illustrating the project need, goal, objectives and accomplishments.
- Funding program options and requirements
 - A grant will be funded by one of the three funding programs. You will need to select one. Contact NCFS U&CF program staff for guidance, if needed.
 - Consolidated Program Grant (CPG)
 - The are no eligibility restrictions.
 - Cost share %
 - Reimbursement of 75% of eligible purchased goods and services.
 - Indirect administration 15% de minimis/total purchased goods and services.
 - \$50,000 in assistance is available for award of all CPG funded RFAs.
 - Hurricane Helene Recovery (HHR)
 - Tribal government or a municipality located in Alleghany, Ashe, Avery, Buncombe, Caldwell, Henderson, Madison, Mitchell, Polk, Rutherford, Transylvania or Yancey counties.
 - Cost share %
 - Reimbursement of 100% of eligible purchased goods and services.
 - Indirect administration 15% de minimis/total purchased goods and services.
 - \$2.2 million in assistance is available for award of all HHR funded RFAs.
 - Inflation Reduction Act (IRA)
 - 100% of the Tribal government or municipality's incorporated lands fall within the boundaries of <u>NCFS U&CF Financial Assistance Program</u> <u>Inflation Reduction Act project areas</u>.
 - Cost share %
 - Reimbursement of 100% of eligible purchased goods and services.
 - Indirect administration 20% de minimis/total purchased goods and services.
 - \$5.6 million of assistance is available for award of all IRA funded RFAs.
