Payment of the examination fee (\$25.00 per phase) paid at the exam site is required before each examination is taken. A check or money order is the preferred payment method. If you passed both the Core Examination and at least one phase examination and wish to obtain your certified applicator's identification card, please download and complete the application and return it to this office, along with a check or money order in the amount of \$50.00. You must obtain your card within six months from the date on which you passed the examination(s). The fee to add a phase to an existing certification is \$5.00. Structural Pest Control Certified Applicator's cards are not prorated; all cards expire June 30th of each year and must be renewed prior to that date if the applicator is to continue working without interruption.
