Inspector's Corner (by David Propoggio)

I've often been asked what is the best- and worst-case scenarios I've run across as a Structural Pest Control Inspector. While I'm known to give straight line answers, I ponder this question as to how it's aged over the years. After all, licensees are not often the same individuals as when they first passed their exam, at least not the more experienced ones and sometimes that can be for better or worse.

Let me start by giving you the worst-case scenario. I'd probably tell you in my younger years it would be inspecting a crawl space, both low and wet while the temperature was over 100 degrees. It might have even been one of me exiting a crawl space out of a vent hole since I was the only one able to crawl it and retired Eastern District Supervisor-Ramon Ortiz taking a picture as proof. But as I egress from this position and stand back a bit, I'd have to say the worst-case scenario is the insidious nature of work performed by unlicensed Structural Pest Control Operators.

These investigations can be exhausting, sometimes taking years to complete and to put it mildly, very difficult to put together. One of our Division's higher priorities is to protect health and the environment, so when individuals decide to go "rogue" by performing unlicensed work, the scope and service that licensed Pest Management Professionals must define is out the door. While I dare not discuss the finer details of these cases, the ones affected the most are probably those reading this article right now. After all, you probably remember the day you passed the license exam exclaiming that you never want to do that again! It was hard work and to recognize it, you were then eligible to apply for your license. After shelling out some dollars and getting insurance you finally received that coveted card with a license number belonging solely to the bearer.

While some may wish to run a thousand miles in hot sand rather than having to take that test again, those who perform unlicensed work get to bypass that whole process, never earning their stripes, so to speak. Those stripes you've earned by becoming familiar with a series of tests, albeit very hard, also gave you the tools to better equip yourselves to effectively handle those customer's pest control issues in a safer and more environmentally friendly manner.

Competency is usually lacking with unlicensed operators and shortcuts to treatments abound, but we do what we can to stop these individuals when we're able. While they take resources away from our department, they also take away work you could have serviced. More importantly though is when those unlicensed individuals perform misapplications and harm our citizens, the Pest Control industry takes the hit. If you suspect unlicensed work being performed, please talk to your inspector to determine the best course of action.

As for the best-case scenario. I loved being able to help homeowner and Pest Management Professional's alike. Having a new licensee however, with a new company we are charged with regulating is an opportunity in the making. It gives us the ability to guide them to meet their regulatory obligations while giving them input to grow their business successfully. It may not always happen that way, but there's a totally different satisfaction to watching a company grow on a solid foundation that makes them successful.

I leave you with this: Back in 2019 during the annual NCPMA PCT School, an NCPMA Chair invited a few of us Inspectors into an impromptu board room meeting. Upon making an introduction, he spoke of lifting all boats. I believe the words of this man was something to the effect of: "Don't speak ill of your fellow industry members to a customer. It does a disservice to the entire industry and makes [us] all look incompetent. Talk about what you would do differently to that customer in a positive way and eventually it will raise the standards. That in part will raise all boats."

I've seen it time and time again about some company performing an inspection talking to a homeowner about how this company didn't do something right and it turned out that representative didn't have all the facts to base that assessment on and they wound up eating crow. The homeowner instantly feels a negative opinion about at least one company. Now overlay what the wise man said where the technician would speak of what his company would do without the negative connotation of the previous or current company. The homeowner is then given a choice between 2 competent companies. A plus for the homeowner and elevating the standard within the industry or in other words, "raising all boats".

The More You Know

- ⇒ You have no more than 75 days, from the date of hire, to attend RT school AND submit a completed RT card application for anyone involved in structural pest control sales, service, solicitation, or estimation. Remember to bring your completed & signed RT Introductory Workbook to RT school with you.
- ⇒ Trainers and companies must both be approved to offer in-house RT equivalency programs. Trainers cannot offer classes for employees of other companies; only employees of the trainer's company will get credit for those programs. For additional information email don.daley@ncagr.gov.
- ⇒ You must submit a new Certificate of Insurance (COI) yearly at the time your insurance policy is renewed. The COI must include a statement that "Pesticide/Herbicide Applicator Coverage" and/or "Transit Pollution Coverage" is included in the policy. New/updated insurance information should be submitted to insurance@ncagr.gov.
- ⇒ After successfully completing your CA/license exam(s), you must then submit an application for CA/ license card, with the necessary fees, to be issued new credentials. Passing exam scores do expire if credentials are not obtained; phase exam scores are valid for 6 months, while the CA core exam score is valid for 12 months.

N.C. Structural Pest Control Committee Announces Case Settlements

RALEIGH – The N.C. Structural Pest Control Committee approved settlement agreements for four cases in Davidson, Durham, and Mecklenburg counties at the *March 22, 2022* meeting held in Raleigh, at the Steve Troxler Agricultural Sciences Center. Following are the agreements:

- Wenasdell Grant, a structural pest control licensee for Home Team Pest Defense in Durham, agreed to
 pay \$18,000 for failing to supervise the structural pest control performed out of his home office and any
 branch office and use of a pesticide inconsistent with its labeling. Multiple technicians under Grant's
 license performed inadequate pre-construction termite treatments.
- Bradley J. Huff Jr., a structural pest control licensee for Sure Kill Exterminating Service Inc. in Lexington, agreed to surrender his license due to a recent felony conviction.
- Arthur D. Capron Jr., a structural pest control licensee for Dodson Bros. Ext. Co. Inc. in Charlotte, agreed
 to pay \$600 for failing to supervise the structural pest control performed out of his home office and any
 branch office and for failure to promptly bring to the attention of the property owner all damaged wood
 members of a structure during a visual inspection.
- Lester Packard, who works for Dodson Bros. Ext. Co. Inc. in Charlotte, agreed to pay \$600 for using any pesticide in a manner inconsistent with its labeling, failure to remove all wood debris and cellulose material in all crawl space areas, and trenching below the bottom of a footing for termiticide treatment.

N.C. Structural Pest Control Committee Announces Case Settlements

RALEIGH – The N.C. Structural Pest Control Committee approved settlement agreements for eleven cases in Brunswick, Buncombe, Cabarrus, Robeson, Wake, and Yadkin counties at the **September 20**, **2022** meeting held in Raleigh, at the Steve Troxler Agricultural Sciences Center. Following are the agreements:

- Peter Hawkins, a structural pest control licensee for Mosquito Authority/Pest Authority in Raleigh, agreed to pay \$800 for failing to supervise the structural pest control performed out of his home office or any branch office under licensee's management and use of a pesticide inconsistent with its labeling.
- John G. Sheen, a structural pest control licensee for Reliant Pest Management in Cary, agreed to
 pay \$600 for failure to pay the original or renewal license fee when due and continuing to operate
 as a licensee.
- Terry S. Canady, a structural pest control licensee for Canady's Services in Lumber Bridge, agreed to pay \$1200 for managing any branch office in excess of the number of branch offices that may be managed by a licensee as set forth in the rules adopted by the Committee and failure to pay the original or renewal license fee when due and continuing to operate as a licensee.
- John Dowless, a structural pest control licensee for Strand Termite and Pest Control in Ocean Isle Beach, agreed to pay \$800 for failing to supervise the structural pest control performed out of his home office or any branch office under licensee's management and use of a pesticide inconsistent with its labeling.
- Johnny Graham, who works for Strand Chemical Company in Ocean Isle Beach, agreed to pay \$400 for use of a pesticide inconsistent with its labeling.
- Richard D. Smith, a structural pest control licensee for Pro Tect Pest Elimination Service in East
 Bend, agreed to pay \$400 for failing to supervise the structural pest control performed out of his
 home office or any branch office under licensee's management, use of a pesticide inconsistent with
 its labeling, and applying pesticide for the purpose of structural pest control where the conditions
 at the site of application favor drift or runoff from the target site.

- James Rhyne, who works for Pro Tect Pest Elimination Service in East Bend, agreed to pay \$400
 for use of a pesticide inconsistent with its labeling and applying pesticide for the purpose of
 structural pest control where the conditions at the site of application favor drift or runoff from
 the target site.
- Timothy Horton, a structural pest control licensee for Pest Specialist in Concord, agreed to pay \$1000 for failing to supervise the structural pest control performed out of his home office or any branch office under licensee's management, failure to execute and furnish to the property owner or authorized agent a written proposal as to the type and quality of work prior to starting treatment, issuing an incomplete or inaccurate WDIR-100 or issuing WDIR prior to inspection of building or structure, failure to issue liability agreement after providing a guarantee, warranty or service agreement, and failure to prepare foundation diagram or site plan of the structure or portions of structure inspected when presence of wood destroying organisms identified.
- John Ellis, who works for Pest Specialist in Concord, agreed to pay \$400 for use of a pesticide inconsistent with its labeling and not using the presence of fresh wood colored frass as acceptable evidence of an active powder post beetle infestation.
- Devin Walker, who works for Pest Specialist in Concord, agreed to pay \$400 for the use of a pesticide inconsistent with its labeling.
- Sheryl Bachman, a structural pest control licensee for Spencer Pest Services in Arden, agreed to pay \$600 for failure to pay the original or renewal license fee when due and continuing to operate as a licensee.
