
LICENSE/CERTIFICATION RENEWALS

All license and card renewal forms, received by our Division, have been processed. Licenses and cards are required to be renewed by June 30th every year. If you have not renewed your license, certified applicator, or registered technician cards, you should contact the Division immediately. Licensees who fail to renew and continue to work after the expiration date of their license, are in violation of the Structural Pest Control Law. If your license is placed on inactive status, you must still renew each year, and maintain your recertification status, by taking the appropriate number of CCU's. Licensees on inactive status are not sent a license certificate but will receive a letter indicating that the license has been renewed. The last date that licenses and certified applicator cards can be renewed, without having to take the exam again, is December 31st. If you do not receive a letter, after renewal of an inactive license, you should contact the Division, well before December 31st, to ensure that the renewal has been processed.

EXAM REVIEW

Numerous calls are received each month from exam applicants wanting to know if the state offers exam prep courses. Our office administers an "exam review" each month that is open to exam applicants who have taken a state SPC certification or license exam that same month, or the previous month, and did not pass the exam(s). Each exam applicant can schedule a one-hour review session per exam. The review sessions are held in our building - The L.Y. Ballantine Building; 2109 Blue Ridge Road, Raleigh. Applicants must contact Tony May; (919) 857-4138 or Tony.may@ncagr.gov to schedule their review session(s). The review sessions run from 9 am to 4 pm with a one-hour break for lunch. There is no fee associated with the review session(s).

Another exam prep type option available to "license exam applicants only" is NC State's Structural Pest Management training and research facility administers a "specimen review" the day before a license exam. The training facility is located on Chi Road just 1 mile south of the belt line (off Lake Wheeler Road) and you can find out more about these specimen reviews by opening this link; https://pesttraining.cals.ncsu.edu/training-programs/license-exam-preparation/. Patty Alder provides onsite assistance in identifying structural insect pests similar to the insect specimens covered on the exams.



N.C. Structural Pest Control Committee Announces Case Settlements

RALEIGH – The N.C. Structural Pest Control Committee recently approved the following settlement agreements at the July 23, 2019 meeting held in Raleigh. Settlements involved individuals in Clay, Cumberland, Durham, Lee, Moore, New Hanover, Union and Wake Counties.

Settlements are listed by county below:

(Clay) Gregory Lohman, license holder for Alpine Exterminating, has agreed to pay \$800 for applying commercial pesticides without a valid pesticide license.

(Cumberland) Kenneth Jordan, license holder for Economy Pest Control, has agreed to pay \$800 for applying a pesticide in a manner inconsistent with its labeling and for failing to supervise pest control conducted out of his office. Economy Pest Control routinely applied the SHOCKWAVE Fogging Concentrate in residential and commercial settings despite the product label stating "do not apply this product as a space spray in any residential or commercial setting. Space spray are only allowed in food handling establishments."

(Durham) Henry Judson-Saunders Smith, operator of HJS Acquisitions; Mosquito TEK LLC, has agreed to pay \$1,600 for making commercial pesticide applications without a valid pesticide license and with lapsed liability insurance, as well as failing to obtain Registered Technician cards for four employees within 75 days of hiring.

(Lee) William J. Ingersoll, a license holder for Sandhills Pest Control, has agreed to pay \$2,800 for engaging in work as a manager, owner or owner-operator in structural pest control without a valid pesticide license, and for failing to supervise structural pest control work performed out of his office.

(Moore) Terry S. Canady, owner and operator of Canady's Service, Inc., has agreed to pay \$400 for failing to supervise structural pest control work performed out of his office.

(Moore) Gabriel Dial, also with Canady' Service, Inc, has agreed to pay \$400 for using a pesticide in a manner inconsistent with its labeling. Dial applied a pesticide directly to the foundation walls and widows of a home, instead of in trenches, as required by the label.

(Moore) Wesley A. Wooten, operator of State Pest Control, LLC, has ag reed to pay \$400 for establishing more than two branch offices in addition to his home office, failing to personally supervise pest control work conducted out of his office and establishing multiple branch offices without filing proper paperwork in Sanford, Wendell and Fayetteville from Nov. 1, 2016 to Feb. 9, 2017.

(New Hanover) Stanley Hollingsworth, owner and operator of Bug N A Rug Extermination, has agreed to pay \$1,200 for engaging in work as a manager, owner or owner-operator in structural pest control without a valid pesticide license.

(Union) George L. Bryce, owner of Crown Pest Control in Waxhaw, agreed to pay \$400 for not actively supervising structural pest control work performed out of his office.

(Wake) Theodoric Taylor, owner and operator of Ardy Taylor Pest Control, has agreed to pay \$400 for making commercial pesticide applications without a valid pesticide license, and for submitting an inaccurate Wood Destroying Insect Report 100 form which incorrectly reported a previous termite treatment when there was none.

N.C. Structural Pest Control Registered Technician School Revision Project

In recent months the Division has met with the N.C. Pest Management Association and N.C. State University concerning a project to revise the entire Registered Technician (RT) School Program. This will include RT workbook revisions and updating the day-long RT School presentation. When this project is completed the entire RT School Program will provide a valuable, interactive learning experience complete with current Structural Pest Control technology that will be easily updated for many years to come. The Division is looking forward to working closely with the N.C. Pest Management Association and N.C. State University on this project to provide quality training for new hires in the Structural Pest Control Industry.
