CHECK YOUR CCU CREDITS

Start checking your transcript now, to make sure you are going to have enough credits, and the correct number of years needed to meet your recertification requirements. This should be done before the June 30, 2019 deadline. Please review your transcript to confirm you have received credits for all the courses attended. If there are errors or omissions on your transcript, contact Michelle Willett by email at

michelle.willett@ncagr.gov or by phone at 919-857-4160. You will need to provide the date of training, topic of training, and name of trainer or sponsor.

Checking your Continuing Certification Units (CCU's) now will give you more choices in selecting available, approved CCU courses. Waiting until May or June can mean there are not as many selections to choose from.

Note: Only half of needed CCU's can be taken online. If you need 10 CCU's to be recertified, only 5 of those can be earned by taking online courses. Also, no credit is given for taking the same course over, during the 5-year recertification period.



2019 PEST CONTROL TECHNICIAN'S SCHOOL (PCT)

The North Carolina Pest Management Association kicked off the 69th Annual PCT School on January 27, 2019. The three day event attracted 1008 pest management professionals. There were 21 different courses, giving attendees the opportunity to earn an assortment of CCU credits. State inspectors scanned attendees' badges at each course held during the school and almost 4000 CCU credits were earned by attendees. This year, the PCT School offered 3 new courses that had not been offered before, including a Hands-On Spray School, the NWCOA Bat Standards Course, and an A.C.E. Review Course and Exam. There were 128 individuals who took the Certification Exam at the PCT School this year! The 2020 Pest Control Technician's School is scheduled for January 26-30, 2020. Be sure to preregister later this year.

EXAM REVIEW

For all exam takers who did not pass your certification or license exams:

The Structural Pest Control section offers these folks an EXAM REVIEW session at the end of each month in our large conference room (2109 Blue Ridge Road, Raleigh). Any exam taker is entitled to a review session (60 minutes) per exam taken and not passed. You must schedule review session(s) with Tony May (Tony.may@ncagr.gov or 919-857-4138) and the monthly review sessions are available ONLY to exam takers from previous 2 months of exams. Review sessions run each hour from 9:00 am - 12:00 pm and 1:00 pm - 4:00 pm. This is a self-directed review session in which the exam taker can review their answers to the exam(s) and learn which questions they answered correctly and what their incorrect answers were. This type of review is valuable to exam takers by helping them sharpen their study focus for future exams they will take. There is no charge for review sessions. Check our web site for dates of review sessions.

BE ON THE LOOKOUT FOR RENEWALS

Structural Pest Control renewals will be mailed by May 1, 2019 for the 2019-2020 licensing year. When you receive your renewal package, please review the following:

Make sure all names are spelled correctly and addresses are correct. Please include your physical address as well as your mailing address, and correct phone numbers. If there are errors, please make legible corrections on the individual forms. If you are missing a form, please contact Jacinth McAllister by email at Jacinth.Mcallister@ncagr.gov. If you need additional forms, please go to our website; http://www.ncagr.gov/SPCAP/structural/forms/index.htm to find the correct form(s) you need.

The cost to renew cards is \$40.00 for each Registered Technician Card, \$50.00 for each Certified Applicator Card and \$200.00 for each Licensee Card for a single phase (P, W, or F) and an additional \$75.00 for each additional licensing phase. All cards expire on June 30th, annually, so send in your renewals by this deadline. The Division accepts payment in the form of check or money order. We are unable to accept credit cards at this time. Please remember, branch office registration expires on June 30th, and must be renewed as well. FEES FOR CARDS ARE NOT PRORATED.

If you did not receive your recertification transcripts and require a copy, please contact a Structural Pest Control Representative. Please keep your transcript for future reference. With so many people on our recertification list it is very challenging to assist callers who ask for this information verbally.

Branch Office forms are not in the renewal package. If you operate a Branch office, you are required to notify the Division annually of the address of each branch and the individuals assigned to it. This is done using the Branch Office Registration forms, found at http://www.ncagr.gov/SPCAP/structural/forms/Branch Office.pdf.

CAUTION! Renewal applications may be denied and returned for the following reasons:

An expired liability insurance certificate. A current certificate must be on file at the Structural Pest Control Office. The certificate must include coverage for pollution and contamination. The insurance expire date is printed on the renewal application.

Incomplete CCU's— If your 5-year recertification period ends this year, all continuing education must be completed for 2019 before renewals are received and processed. Check CCU status at http://www.ncagr.gov/SPCAP/LicenseSearch.htm. From the dropdown menu choose Structural Certified Applicator or Structural Pest Control Licensee. Enter either last name, Company, License and/or File number to the search box.

WHY IS THERE A COMPLAINT REGARDING MY WDIR-100?

WDIR request inspections continue to be the leading cause of consumer complaints that the Structural Pest Control Section receives. Wood Destroying Insect Information Reports are not intended to be used as sales tools. They should be utilized as the name states- "Information reports." It is the PMP's responsibility to provide accurate information regarding visible evidence of wood destroying insects found on the <u>actual date</u> of your inspection. Remember that when your WDIR indicates any issues the seller will more than likely call another company to confirm your findings and possibly get another quote. Also, when there is a difference of opinion our Section will normally get a phone call or email requesting an inspection of the structure. An inaccurate WDIR is a secondary deviation and can possibly lead to more regulatory action. Please remember that your company liability increases significantly when an inaccurate WDIR is issued and this could potentially be very expensive for your company.

Take your time and perform a thorough inspection! It is not uncommon for our Field Inspectors to spend several hours inspecting and documenting their findings of the structure. Our Inspectors are sometimes informed by consumers that "the pest control technician was only there for twenty to thirty minutes." This appears to be the primary reason why our inspectors continue to find wood-destroying insect evidence and other issues that are not indicated on an inaccurate WDIR.

Common WDIR issues found by our SPC Field Inspectors:

Inaccessible/obstructed areas:

This information must be clear and precise. There should be no doubt concerning which area of the structure you are addressing.

All evidence of Wood Destroying Insects are not being reported:

Don't stop your inspection after finding initial evidence. Inspect the entire structure!

Accurate location of evidence:

General locations are not acceptable. Your description of the location must be <u>specific</u> to clearly indicate the location of visible evidence of infestation. Example: "In crawl space" is not sufficient but "in floor joists behind front porch" would be a specific location explanation.

Evidence of a prior termite treatment (with no termite evidence):

This is not evidence of termites and should not be listed as such.

Conditions conducive to subterranean termites:

At a minimum, wood to ground contact, cellulose debris, and excessively wet wood as determined by a moisture meter are required to be reported.

Structural Pest Control Committee News

At their January 10, 2019 meeting, the Structural Pest Control Committee discussed the issue of license holders allowing their liability insurance to lapse. Therefore, the Committee directed that the Structural Pest Control and Pesticides Division remind license holders that pursuant to 02 NCAC 34 .0902(c):

"Each applicant for a license in any phase of structural pest control shall show evidence of his financial ability to properly indemnify persons suffering from the use or application of pesticides in the form of a Certificate of Insurance completed by the insurance company with the Division named as a certificate holder."

This means that you must list the Structural Pest Control and Pesticides Division as a certificate holder on your general liability policy so that the insurance company will notify the Division of any cancellation of the policy. Please list insurance@ncagr.gov as the preferred notification method for the Division.

Please note, listing the Division as a certificate holder does not relieve the licensee from their responsibility under 02 NCAC 34 .0902(g) to provides the Division with notice 10 days prior to any cancellation of the policy, material change in the policy, or reduction of the available coverage under the policy below the minimum requirement limits.

N.C. Structural Pest Control Committee Announces Case Settlements

RALEIGH –The N.C. Structural Pest Control Committee recently approved settlement agreements for cases in Chowan, Mecklenburg and Wake counties at its Jan. 10 meeting in Raleigh. Following are the agreements:

- (Chowan) Earl Bassett III, owner and structural pest control license holder for A-2-Z Pest Control and Wildlife Removal in Edenton, agreed to pay \$400 for performing structural pest control work without a valid license. Bassett's pest control license lapsed between July 1 and Aug. 17, 2017 and he invoiced nine P-phase pest control accounts during that time.
- (Mecklenburg) Christopher G. Cramer, structural pest control license holder for Cramer Pest Control in Pineville, agreed to pay \$4,000 for performing \$128,825 of structural pest control work from July 1, 2016 to July 14, 2017 without a valid structural pest control license.
- (Wake) Lance Hines, owner and structural pest control license holder for Mayday Pest Control in Holly Springs, agreed to pay \$1,200 for performing a total of \$62,834 of structural pest control services during a six-month lapse in liability insurance. A structural pest control license holder must maintain liability insurance under the N.C. Structural Pest Control Law.
