Animal feed labels will often contain additional, voluntary marketing information. All claims must be truthful and not misleading to the purchaser. Animal feeds are a food product and cannot have any drug claims made about them.

Ingredient Statement

The label must include a listing of all ingredients, listed in descending order of predominance by weight in the product. →

Guarantor Information

The entity responsible for the product with their name and city, state, and zip code listed at minimum.

← At minimum, feeds must guarantee these three nutrients. This provides the purchases with information regarding the amount of basic nutrients about the feed. Additional guarantees may be required and/or made voluntarily.

Feeding Directions

← Directions for the purchaser on how to safely and effectively feed the product.

Net Weight Statement

← Each package must contain an accurate statement of net quantity in ounce - pound units and the respective metric unit.
