- There are no limitations to the number of entries per category.
- Each nomination of new and innovative practice must have taken place during the 2017-18 school year.
- We want to help tell your story. Please include details, supporting data and photos along with sharing the impact the practice has had on your school breakfast and lunch programs. Please note that, due to email securities we have in place, **we are unable to receive Google Docs software files.**

attachments. A panel for each of the awards will judge nominees and the winners will be revealed during the annual SNA-NC Conference in Greensboro in June. The award itself will be formally presented at the Annual Conference for School Nutrition Administrators in October of 2019.
