North Carolina Feed Report

July 1, 2018 – June 30, 2019

The objectives of the North Carolina Animal Feed Program are threefold. The first is the protection of livestock, poultry, and pet owners by monitoring feed quality, checking labels and plant inspections. Next is the protection of manufacturers from dishonest competition. Finally, the protection of the health of the consumer of meat, milk, and eggs through assurance that the animal products consumed are wholesome and free of harmful chemical residues and BSE. Enforcement of the feed law is the best means of accomplishing this. Essentially, the procedure consists of registration of all commercial feedstuffs and canned pet foods, the collection and analysis of official samples and the reporting and publishing of results.

The law requires the registration of all commercial feeds, canned pet food and pet and specialty pet feeds with the Department of Agriculture and Consumer Services. Applications for registration are examined as to guarantees, composition, compliance with standards, adequate directions and other requirements. When requirements are not met, opportunity for revision is given. The laws, along with the rules and regulations, and all registration forms are available at the following web site: www.ncfeedandforage.com.
