- **F.** (Log, pulpwood, and/or wood chip) staging or holding areas must be (set suitable distance) away from standing trees.
- **G.** During the five months of April through August, the establishment will safeguard Regulated Articles when the Regulated Articles originate in a non-infested area. The Regulated Articles must move directly through regulated areas without stopping (except for refueling or for traffic conditions, such as traffic lights and stop signs). Regulated Articles exposed during transit will be treated as infested articles.
- **H.** PPQ and State Department of Agriculture inspectors retain the right to (1) make spot checks of shipments, (2) monitor inspection procedures and (3) examine records of shipments to locations outside of the generally infested area.
- **I.** If the establishment fails to comply with provisions of the agreement and/or the gypsy moth regulations, this Compliance Agreement will be canceled. When a cancellation occurs, each shipment will require individual inspection by a PPQ or State inspector; in addition, cancellation could result in the assessment of civil penalties.
- **J.** The U.S. Department of Agriculture will furnish the service of the PPQ inspectors without cost. Other than the service of the PPQ inspector, the U.S. Department of Agriculture will not be responsible for any costs or charges incident to inspections or compliance with the quarantine.
