These applications are in several stages of processing. They're either pending, eligible, preapproved, or approved. These applications are only reflecting our 2018 Farm Bill programs.

Additional Funding

NC NRCS requested an additional \$10 million in funding that will be used to implement conservation practices throughout the state.

For FY 25, NRCS has been given the authority to proceed with processing farm bill payments for existing contracts obligated using Inflation Reduction Act (IRA) funds.

General Updates

Partnerships Programs

On April 14, Secretary Rollins announced the cancellation of the Partnerships for Climate Smart Commodities (PCSC). It is being re-launched as the Advancing Markets for Producers (AMP) Initiative. USDA will review existing grant agreements based on three policy priorities:

- A minimum of 65% of federal funds must go to producers;
- Grant recipients must have enrolled at least one producer as of 12/31/2024; and
- Grant recipients must have made a payment to at least one producer as of 12/31/2024.

USDA will honor all eligible expenses incurred prior to April 13, 2025. This reform effort will utilize existing funding, with no new funding made available for these partnerships.

General Updates Cont.

Emergency Watershed Protection Program (EWP)

The EWP deadline for areas that were affected by TS Helene ended on April 11, 2025. NRCS NHQ has approved an extension with a deadline to be finalized later, tentatively scheduled for May 30. The current list of sponsors include:
