### **Spot Check Policy**

The Commission delegated responsibility to district boards of supervisors for assuring that best management practices, funded through Cost Share Programs (CSPs) contracts, are properly implemented and maintained.

The Commission requires supervisors spot check 5% of active contracts per program annually.













### **Spot Check Policy**

**In Compliance -** BMPs are functioning properly and being used for their intended purpose of the program.

In Compliance, Maintenance Needed - BMPs need routine maintenance such as reseeding of vegetation, adding mulch, gravel, etc.

**Out of Compliance-** BMPs are <u>not</u> functioning properly or <u>not</u> being used for their intended purpose of the program.













### 2025 Summary

Annual spotchecks were received from **100** districts.

#### **Highlights**

211 district supervisors participated in spot checks

8 districts submitted reports after the deadline

937 contracts were spot checked across all three programs

45 contracts had BMPs requiring maintenance

14 contracts had BMPs that were out of compliance

### Helene Impacted Contracts

Program	Number of Contracts
ACSP	7 (only maintenance needed)
AgWRAP	2 (all compliance cases)

- 3 of these contracts have repair contracts in place.
- Others are waiting on funding or TA requests to assess the damage and how to repair the practice













# FY2024 Spot Check Follow-up

### **10 BMPs Found Out of Compliance in FY2024**

AgWRAP	5	11	13	3
CCAP	1	2	2	1













### Process Improvements for FY26

- Several districts submitted Spot Check Reports after the deadline
  - 8% of districts submitted their reports late
- Some districts did not spot check the 5% of active contracts per program
  - 9% of districts did not meet the 5% minimum of active contracts per program
  - Two districts did not have technical representatives from their districts present on the spot checks, which the Division has not seen previously
  - One district did not have a supervisor present on one of their spot checks
- Division staff have started the process to improve the spot check process
  - Division will develop new training tools for district supervisors and staff
  - Working on new tools for districts to use for contract selection
