



50% Progress Updates

- FY2024 StRAP Contract requires that Grantees submit a report documenting progress towards having 50% of funds encumbered towards contracts

Grantee shall submit a Streamflow Assistance 50% Progress Report by end of business hours on August 28, 2025. The report will provide detailed information on the contracts that have been approved and executed for the project. This report requires the grantee to show 50% of contract funds being encumbered by contracts. The report is also subject to the review and approval of the Soil & Water Commission.

- **Status:**
 - 65 grantees have encumbered at least 50% of funds
 - 35 grantees have NOT encumbered at least 50% of funds
 - 10 grantees have not yet submitted 50% progress reports
 - 1 grantee declined funding
- \$13,723,724 currently encumbered.

- Reasons 50% Encumbrance was not reached:
 - Delays caused by Hurricane Helene.
 - Including waiting on FEMA to complete work so StRAP funds can be used on sites not covered by FEMA.
 - Engineering/Permitting Requirements.
 - Projects coming in under budget.
 - Allows additional sites to be added to scope of work.
 - Prioritizing pre-existing contracts before starting on FY2024 contracts.
 - No bids received in first bid opening.
 - Loss of staff overseeing project.
 - Land access issues.
