
Helene-StRAP Allocation

- \$40 million total funding for Helene-Related Projects
- DSWC can retain 5% of funds for admin costs
 - Staffing costs (including new hires), inspectors, software, vehicles for site visits, equipment, etc.
 - Leaves \$38 million available for awards.
 - Grantees can use up to 15% of awarded funds for administrative expenses (same as previous rounds of StRAP).
- Limitation on Helene-funding: "Shall not expend funds ... On any activities that will be, or likely will be, covered by federal funds." Waiting for site approval by:
 - FEMA/Army Corps of Engineers
 - Emergency Watershed Protection Program (EWP) through NRCS



EWP Enrollment

- 27 organizations applying for EWP
 - 11 organizations have submitted FDRs
 - 225 DSRs submitted to date
 - 47 sites denied for funding by NRCS
 - Total requested funds to date: \$71.4M
 - 16 counties have no organizations requesting EWP
 - 1 high need
 - 7 medium need
 - 8 low need


• **Division Recommendation**: Accept applications for all project types and allow grantees to choose locally which projects to prioritize.

County Categories

- High Need- identified as Most Impacted and Distressed (MID) Areas by Dept. of Housing and Urban Development, NC Dept. of Commerce, NC State Action Plan
- Medium Need- identified as next highest impact by NC Dept. of Commerce, NC State Action Plan
- Low Need- all other affected counties in FEMA disaster declaration
- Percent of affected counties in each proposed category (and self-identified need):
 - High Need: 40% (41%)
 - Medium Need: 32% (32%)
 - Low Need: 28% (27%)



Supplemental Awards

- Supplemental Award Options:
 - 1. Any unused/returned/declined funding will be re-allocated to ensure all available funding is used.
 - 2. A portion of total funds may be withheld for a supplemental allocation after all rounds of applications are completed.
- If used, supplemental awards would be determined after all counties have received an award.
 - Would limit initial county awards.
 - Grantee's project selection/implementation may be on hold until all funding is issued.
 - DSWC/SWCC would have to identify which factors should be considered in determining recipients.


Application Process


- Rolling Applications
 - 1st Application Window: will include any counties that have completed EWP enrollment or are not applying for EWP.
 - Counties to be included in 1st application window will be finalized following update meeting with NRCS on 11/20
 - Subsequent application windows will open as other counties complete EWP enrollment.
- 2-part Application:
 - **Disaster Assessment Recovery Tool (DART)** will be used to record site information
 - Formerly know as EWP/StRAP site assessment tool (in Survey123)
 - Information available on StRAP website: https://www.ncagr.gov/divisions/soil-water-conservation/programs-initiatives/strap/disasterrecovery
 - **Formsite-** once an applicant has entered all sites in DART, they will fill out a brief form to identify total funding request and which sites should be considered part of application




Application Process- DART

Through application process, DSWC will host ongoing trainings on using DART









Application Process- Length of Applications

- Length of Application Window(s)
 - Planning workgroup feedback:

How long would you like
the StRAP application
window to be open?

5-7 weeks	50%
8-10 weeks	38%
11+ weeks	13%

- Division Recommendation: 8-week application window
 - Grantees can begin submitting sites to DART immediately (but will not be reviewed until application window closes)
 - EWP sites may need additional information added before consideration for StRAP.



Application Review

- Once each round of applications closes, DSWC will review applications
- Award will be determined based on total need/request shown in Application
 - DSWC will not select individual sites for funding.
- Factors considered during ranking will be similar to 2024 round of StRAP:
 - Total request for funds
 - Infrastructure benefitting:
 - Structures
 - Utilities
 - Roads/Bridges
 - Acres of Farmland
 - Other potential benefits
- If multiple applicants within a county, ranking will be used to divide funding between applicants, up to county cap.



Application Process- Timeline

- 1. DSWC begins 1st application window (early December)
- 2. Applicant fills out application (2 parts to application)
 - 1. DART- majority of application- used to submit information for each site/project.
 - 2. Formsite- brief form to identify total funding request and which sites should be considered part of application
- 3. DSWC reviews applications and determines awards.
- 4. Once DSWC determine funding awards:
 - 1. Applicant notified of award amount
 - 2. Once awarded funds, grantees will draft Scope-of-Work (SOW) to identify which projects from application they will use awarded funds on (if award is insufficient to cover all applied sites).
 - 3. DSWC sends Contract to Applicant.
 - 4. Applicant signs and returns Contract.
 - 5. Work begins
- 5. Next application window opens once county(s) have completed EWP enrollment (does not have to wait for previous application windows to close first).
- 6. Scope of Work Revisions (ongoing)
 - Grantees will be able to change SOW in future as needed.
 - If future federal funds can cover any sites on StRAP SOW, grantees should prioritize use of Federal funds and re-allocate StRAP award to be used on sites that don't qualify for federal funding.



Districts and other Applicant Organizations

- Organizations Eligible to apply for StRAP:
 - Soil & Water Conservation Districts
 - Political subdivisions (city/county government, water/sewer district, municipal service District, sanitary district, drainage district)
 - Nonprofit Organization
- Workgroup feedback:

Division recommendation: After applications submitted, DSWC notifies all
