- 12. NC Soil & Water Conservation Commission (Commission): Ann reminded the Supervisors of the next scheduled meeting of the Commission September 17, 2025 and provided copies of an email announcing same.
- 13. NC Association of Soil and Water Conservation Districts (Association): Ann provided information regarding Standing Committee nominations.
- 14. NC Foundation for Soil and Water Conservation (Foundation): Ann provided the Supervisors with copies of an email from the Foundation announcing the winners of the Careers in Conservation scholarships.
- 15. USDA-Natural Resources Conservation Service (NRCS): Anthony Hester, Team 14 Supervisory Soil Conservationist, provided Ann with copies of his written report on NRCS activities for distribution to the Supervisors in his absence. The report included information on a National Civil Rights Compliance Review held on September 11, 2025, USDA reorganization plans, and updates to work accomplished in the Environmental Quality Incentives Program and the Conservation Stewardship Program. Staffing and a hiring freeze were also reported on.

16. Having concluded the regular business meeting of the Board of Supervisors, Chairman Allen announced that he is stepping down as Chairman of the District's Board of Supervisors, effective immediately, due to relocating to a new primary residence outside of Beaufort County. As confirmed by Kristina Fischer, District Operations Section Chief, Division of Soil and Water Conservation, through Amber Rights, the relocation of his residency excludes the possibility of continuing as a Supervisor on Beaufort's Board of Supervisors. This creates a vacancy on the board for the unexpired term of Chairman Allen – 2022-2026. Citing NC General Statute Chapter 143-318.11, Subsection (a), Item (6), Supervisor Cayton offered a motion to enter closed session to discuss the board vacancy and the election of new officers. Supervisor Black seconded the motion. The motion was approved.

All Supervisors, Staff, and Regional Coordinator remained in attendance for the closed session.

Action Item Number 16 was reviewed and recommendations discussed.

Following review and discussion of Action Item No. 16, Supervisor Black offered a motion to return to open session. Supervisor Griffin seconded the motion. The motion was approved.
