



Item Number	Explanation of Inadequacy (circled items above) And Recommendation For Compliance	Date Corrections Must Be Completed
	This is a "New" Licensing inspection today.	
	At the 2/10/10 Courtesy inspection the shop was in the construction stage. Today the owner has completed construction and opened last week.	
	The K-9 room contains cage enclosures for the dogs but the room has also been constructed of materials that are impervious to moisture so the dogs may have access to the entire room. This room will serve as the K-9 Kennel and exercise area.	
7)	K-9 Room - a small box was built to enclose some building support bolts. This box has been chewed. Advised owner to re-seal the chewed spots and to cover this box with a non wood material. Even if cages are positioned in front or over this box, it still must be resealed and covered in a non-wood material if dogs have free time in this room.	
	The feline room meets the AW requirements. This room is not constructed of full height walls so cats will not have free time in this room.	
	The isolation area has been designated but the owner does not have the enclosure in place today.	
	The store is clean, cleaning products and procedures have been reviewed.	
	Records are available for inspection with all the required items.
