Item Number	Explanation of Inadequacy (circled items above) And Recommendation For Compliance	Date Corrections Must Be Completed
1)	Housing Facility - Structure + Repair - Metal Doors - All metal doors that are rusted / Corroded need to be addressed either by replacement or repair.	
3)	Lighting - All non-burning lights need to be addressed by replacing bulbs or balast.	
4)	Floors - Need painting - manager plans to complete them when walls are finished.	
7)	Primary Enclosure - Structure + Repair - Kennel # 34, gate needs attention, Ken. # 52, tracks for guilotine door need attention. Continue to perform regular "Wire Patrol" which means checking for loose or damaged wire and the condition of the pipes. Feral Cat Room - Cages - The pans under the cages are rusted which makes cleaning difficult and the strenght of these cages is a large concern due to the fact that they are used to house just the feral cats with unknown Rabies vaccination status and the fact the staff who handle them are not vaccinated for Rabies makes it a greater concern. Feral cat cages need to be made of a strong, easily sanitizable material and the safety of the handler kept in mind. Management needs to look at replacing all the feral cat cages which could be done in stages.	
<b>Comments:</b> Shelter now has an exercise yard - 5 foot fenced area on good grass. Discussed w/ manager to keep grass well attended: no bare dirt; may want to use gravel if there are areas that are hard to keep grassed. Shelter is in process of being painted now.
