Item Number	Explanation of Inadequacy (circled items above) And Recommendation For Compliance	Date Corrections Must Be Completed
1)	Outside Kennel Area - All 3 doors need attention - 1 needs to be painted, 1 has exposed nails protruding and broken wood, 1 has damage from dog teeth. Paint, repair or replace as the needs fits. Outdoor area - exercise yard - the unpainted areas on the building need to be painted including the block wall.	
3)	Lighting - Outdoor Kennel area (runs) - There are 2 sets of lights not working. Need to replace or repair - all lights must be working.	
2)	Rubber Coated wire bottom cages - Much of the rubber is worn from the wire. Need to replace or clean rust and repaint wire.	
25)	Vet Treatment - Medical Log - Need to name of medication and strength and require owners to identify all prescription medication.	
Comments:		
Owner was not present at inspection today. Advised Kennel attendant on the space requirements. 2 mastifs were being boarded and I was advised that they are housed inside at night in cages. Owner needs to take caution when boarding massive breed dogs that his space is adequate. Pens were clean, odors were minimal, dogs were out in exercise pens. Remember AW inspects the building as well as the dog enclosures and to keep all well maintained. Re-Inspect in 30 working days.
