Follow-up from 9/22/09		
Items Addressed:		
1-	3 doors to the outdoor Kennel area have been stained (1) and painted (2).	
2-	All lighting in the outdoor kennel area now works.	
3-	Kennel now knows to record the strength of all preg. meds.	
4-	The rubber coated wire bottoms for the green fiberglass cages have been removed and new bottoms are on order.	
5-	Outdoor Ex. Yard - Unpainted areas - Kennel assistant stated these areas were stained by the owner but this made little difference in improving the appearance of the building.	
Items still to be addressed:		
1)	Outdoor Ex. Yard Area - The door and wood trim still give the appearance of needing attention. There is deterioration (decaying) with some of the wood molding on the back of the building. These areas need to be improved.	
2)	Green Fiberglass Cages - New Rubber Coated wire Bottoms are ordered but not available today. These cages and pens need to be more thoroughly cleaned. Tan cages used for boarding and grooming need damaged areas repaired.	
3)	Outdoor Ex. Yard needs to be cleared of all "Junk" old welded wire cage, decayed board, grill, chainlink wire. This area should be kept neat & well maintained.	
Comments:		
There is concern on space for large breed dogs. There were no dogs being housed inside today although a Mastiff is in the outdoor run. There must be inches clearance front and back, the dog be able to sit, stand and lie down comfortably in what ever enclosure. Owner needs to consider obtaining larger enclosures for massive breed dogs or not board massive size dogs. Re-Inspect in 30 calendar days.
