**ITEMS TO BE COMPLETED IN THE FOLLOWING TIME
SCHEDULE:**

1. Perimeter fencing is damaged, repair or replace
June 30, 2007
2. Ventilation in office area poor, increase ventilation
January 1, 2008
6. Water drainage throughout facility is very poor, standing water in kennels, storage areas, cat room, livestock areas. Improper drainage in drop of kennels, system needs to tie into existing septic system.
June 30, 2007
7. Chain link in Dog kennels is damaged, much of it beyond repair, replace.
June 30, 2007
8. Overcrowding in both the kennels and cat cages. Reduce number of animals per primary enclosure
January 1, 2008
9. Poor ventilation throughout facility, extremely poor in kennel areas, increase ventilation.
January 1, 2008
12. Odor in kennel areas and cat room in part due to poor ventilation and poor drainage.
January 1, 2008
13. Concrete floors are cracked and unsealed, repair or replace and seal or paint making surfaces impervious to moisture. Linoleum flooring in cat room is damaged and rolling up, mold also noted, replace flooring
June 30, 2007
14. Kennels are constructed in away that allows cross contamination from waste and wastewater from animals in other enclosures. Primary enclosures shall be constructed so as to prevent such contamination.
June 30, 2007
21. A sufficient number of employees shall be utilized to maintain the prescribed level of husbandry practices.
June 30, 2007
30. Gasket on Co Unit needs to be replaced.

SHELTER STAFF AREAS OF CONCERNS

1. To replace windows in office area where the gas seals are broken.
2. To paint and seal walls in kennel areas.
3. Improve lighting in kennel areas.
4. Paint utility room in office area.
5. To clean and seal floors in office areas.
6. Improve lighting and install fans in stray cat area (shed)
7. To replace screens in kennel areas (front screens have been completed)
8. Secure area needed while unloading rabies suspects, bite animals, and dangerous animals to prevent escaping and potential injury to employees and general public.
9. Overcrowding was not observed on second inspection date due to time of year, but anticipates overcrowding problems in spring and fall.
10. There was no animal shelter attendant working on date of inspection.
11. The back livestock area needs stone to facilitate proper drainage and grassing other damaged areas caused by pig.

REINSPECTED ON January 30, 2007 ITEMS COMPLETED

- 3. Poor lighting in main office area.**
- 4. Ceiling shows signs of water damage, Pos. Leak**
- 10. Cats housed in expanded metal cages have no solid resting surfaces or litter boxes, provide solid resting surfaces and litter boxes. (1/1/07)**
- 18. Fecal material, hair, and debris noted around drop off kennels, remove prior to cleaning to prevent buildup.**
- 19. Food and water receptacles are chewed and damaged. Replace with more durable receptacles or disposable. (food)**
- 22. Wet puppies and cats, animals must be removed from primary enclosures if hosing or flushing method is used to clean.**
- 29. Animals that are sick or diseased, injured, lame or blind need to be provided with veterinary care or be euthanized providing it is in compliance with any state or local law requiring a specified holding period.**


