	We received another complaint about Camp Bow Bow located at 1710 Page Rd. The complaints have been discussed with the owner Mr. Neil Bleau.	
	One issue was that a rat bit an employee. There was no date given by the complainant. Mr. Bleau advised that (2) years ago a mouse did bite an employee. After the mouse bite Mr. Bleau contacted an exterminator who treated the building. There is no evidence now of a rodent problem. Mr. Bleau showed me the contract with the exterminator.	
	The next issue addressed by the complainant was that the air conditioner was not turned on until it was hot inside the building. This building has a sensor that determines when to activate the cooling and heating. If the system malfunctions then an alarm sounds.	
	Another complaint was Mr. Bleau selling dogs and keeping the money. Mr. Bleau adopts dogs from animal shelter, that are to be euthanized. The dogs are given veterinary care and Mr. Bleau personally pays for this service. Once the dog is adopted Mr. Bleau only charges what money he has personally invested. Mr. Bleau does not make a profit. I observed an actual contract, that Mr. Bleau had utilized. (I have attached a blank copy of the forms utilized.)	
	Again everything else is well within compliance.	
	Mr. Bleau has requested a copy of the email and any other related correspondence. I advised Mr. Bleau to contact our office for him to receive the correspondence.	
	This is a very well maintained facility.
