Dogs will be supervised when in outside play yard to ensure there is no contact with wooden deck posts. If posts become damaged or chewed they must be covered or replaced with material impervious to moisture. Ensure that all records contain the following: description of dog, owner information, boarding contract that states if commingling is allowed, rabies vaccinations, sign-in/sign-out, and med charts (if any meds are given). Ok to license.
