-------------	---	------------------------------------

1) All electrical outlets within reach of dog/cod must be capped - keep electrical cord out of dogs reach.
 Mattress in suite room that is torn must be removed.

All Chewed/scratelid moldings, inside. Primary enclosures must be replaced w/non-wood material or painted again.

2) Wire on crates that is loose or torn must be repaired or replaced.

Be sure any upholstered furniture that is in primary enclosures is fully covered w/material that can be washed + sanitized or that must no longer be used.

Do not recommend using scratching posts unless they are changed between groups of cats

22) Dogcage - Small dog room - Only 4 dogs may be allowed out together at one time in primary enclosure (room)
 Remember one person per 10 dogs in exercise areas.

Remember outdoor exercise area needs to be good grass - need to consider gravel if grass cannot be maintained.
