	All inadequacies have been completed. From 8-30-07 the following has been completed:	
2)	AC units are now completely finished in main Kennel and separate cat house	
3)	Lighting - cat house lighting is now complete. Outside lights now work.	
4)	Isolation room - Cracks have been sealed.	
7)	Door between office and Kennel - Kick plate has been installed.	
13)	Isolation signs have been created and posted.	
15)	New refrigerator is here now and is working.	
17)	No sign of a flea problem in cat house.	
	Comments: Manager - Patti - started a separate "Meds Log" today - the old record was not specific enough. Discussed the upcoming need to re-paint the cat cages in the main Kennel room and to thoroughly clean the cat cages in cat house - they have small mesh metal that attracts dust and hair and requires a more detailed cleaning especially on the outside - inside is clean. Remember to do "landmine" patrol in outdoor exercise area twice a day. Records are in order - dogs and cats look healthy - Temperature is 78° in both areas.
