


	<p>Since the last inspection, Safe Harbor has added a screened porch for an exercise area for the adoptable cats. They have also begun using their new building for their dogs. This indoor building has 11 fiberglass cages, 3 pens for large dogs and multiple solid and folding wire crates. The building is insulated, has linoleum floor covering, heat and air, hot water refrigeration, food storage and restroom facilities for the staff. Attached to the building is a concrete exercise area, 3 chain link pens which are covered. There is a gravel area to which the dogs are taken to and encouraged to use only this area for relieving themselves. Feces is scooped, the gravel is washed and other areas are cleaned with the mop method. A area has been prepared for the generator and the sheltering cover is being built.</p> <p>At this time there is a new 16 x 24 building under construction that will be used strictly for isolation.</p> <p>The area around Dr. Swanson's motorhome is used only for her personal dogs. Discussed ground cover.</p>
