7)	Primary Enclosure - Inside Kennels - Left side has 9 walls - Right side has 6 walls - Either the shower board has been damaged from scratching or chewing by the dogs or the moldings have been damaged. All the damaged material needs to either be taken down and painted or apply more non-wood material on the unsealed block walls.	
18)	Grounds behind the outdoor Kennels - The pens were clean today at inspection time but there is much hair buildup in the gravel that is there for drainage. The hair is a source of flies and odor. Discussed installing large PVC pipe that has been cut lengthways in half and drilling small holes that the water will drain yet contain the hair.	
Comments:		
Since last inspection the shelter has added more gravel to the outdoor pens yard. A large metal container has been brought in to store the extra portable kennels.		
The new 9 gauge 1 inch chain link has been installed and there is no damaged chain link today.		
A new pet sense has opened and shelter is adopting cats through them - discussed details of record keeping with shelter and store.		
There were a few flies today - discussed cleaning protocol - not to throw shovefulls of feces in dumpster but rather to bag it first and then dispose of in the dumpster.		
Discussed setting up temporary pens on the outdoor concrete area so inside kennel walls may be addressed. Advised to remember this would be outdoors and to provide the adequate housing.		
Shelter is conditionally approved contingent upon addressing #7, #18. Re-Inspection will follow in 60-90 days.
