<u>Items addressed since 5-19-09:</u>		
<u>1-</u>	<u>Lighting - Non-working lights have been replaced or repaired. The old surgery room or dog play room is not being used except to store extra cages so the one set of lights working are adequate. Manager discussed using this room to house the Petsmart cots and was advised it was acceptable if they are kept in the cages and the cages not placed next to the walls and to have all the lights in working order.</u>	
<u>Comments:</u>		
<u>Management needs to look at the outdoor kennels - chain link and pipes - these are beginning to need to be painted. Shelter should be pro-active in order to avoid a disapproved inspection. As of today the kennels are approved but it is evident that they will be needing attention in the near future.</u>		
<u>Advised manager to watch closely inside kennel walls that have paint issues and to keep those areas re-painted as needed.</u>		
<u>Records - remember to always record full origin and disposition information on all dogs and cats.</u>		
<u>Temperatures are in range in all areas today at 2:00 pm</u>		
<u>Grass needs mowing - was advised a new battery was on the way for the mower.</u>		
<u>Discussed keeping a sufficient amount of gravel in the play yard.</u>
