	Items that have been addressed since 4-22-08:	
	1- All runs have resting platforms now.	
	2- Dogs are being rotated as pens are holed to be in compliance on Cross Contamination issue. Shelter still plans to install runs that will prevent cross contamination.	
	Items that need to be addressed:	
	6) 7) Cross Contamination issue.	
	7) 'Wire Patrol' - wire needs attention in several runs - must keep all chain link in good, safe repair. 5 th of run on right has a bent pipe that needs to be replaced.	
	17) 20) Feed Room - mouse droppings were found under feed pallets. Any torn or open bags of food must be stored in a closed container. Feed room needs a thorough cleaning and rodent control.	
	31) Disposition records show injured or sick dogs/cats are not being treated or euthanized in a timely manner. If shelter does not provide care for sick or injured dogs/cats they must be euthanized as soon as possible unless they are being held for legal reasons - protective custody - bite cases.	
26)	Discussed Disposition records going with animal when adopted - Control number must be on receipt for trace back if needed.	
	Temperature was 80° at 11:00 AM - No visible signs of illness noted today.	
	Re-Inspect in 30 days.
