Follow-up from 8-20-08		
Items - Inadequacies that have been addressed:		
1-	Outdoor Kennels with damaged wood - These areas have been covered in aluminum so now no wood is within a dog's reach.	
2-	Outdoor Exercise yard - More gravel has been hauled in and holes are filled.	
3-	The exam rooms are no longer being used to house Cats.	
4-	The exam rooms are being worked on - removing torn wall paper and painting - to be used as visiting - banding rooms.	
5-	Grounds maintenance has been performed.	
6-	Animal Id is on Kennel doors.	
7-	Records of Origin - Manager is now paying attention to getting the intake # of any animals adopted from the local AC.	
8-	More personnel are now available to maintain the shelter.	

Inadequacies still to be addressed:

- Exam Rooms - Complete project - removing torn wall paper and painting.
- Dog Play Room - Fix hole in dry wall and torn wall paper.
- Kennel Areas - Cracks in concrete - seal. Manager stated a new worker with knowledge of repairing concrete has joined the staff and these cracks would be fixed.
- Dog Kennels with peeling paint - Manager stated a new paint has been purchased for painting these areas.

Temperatures were 70° - 72° at 12:30pm. All areas of the shelter were clean. The City is installing a Solids separator at the Kennel. No evidence of flooding was seen today from the recent large rains. It still appears this canal needs to be cleaned out from the amount of dead fall it contains.

Re-Inspect in 30 days.
