New inspection performed for licensing. Partition wall has been put up between boarding dogs and breeder's dogs. FRP board has been put up between crates to prevent cross contamination. Gravel has been added around perimeter of outside play yard and to cover bare dirt areas. Wooden posts have been removed from this area and replaced with metal. We discussed having a contract and a sign in/sign out sheet in place when boarding begins. Each boarder must have description, vaccinations records and owner information. If medications are given this must be recorded showing date, time, description of meds, amount and initials of person administering. I explained that if commingling occurs owner must give written consent. Application has been sent in to office. OK to license.
