Continued narrative. Items to Address:

0201 & 0207 Facilities & Sanitation - There were 4 piles of old feces found in the outdoor exercise yard today. Feces must be removed at least 2 times per day.

0204 Primary Enclosures - Old pen inside outdoor exercise yard must be taken down. Pen has a dirt floor and wood and old hay in the dog house. None of this is acceptable in a dog enclosure. In the past the owner was advised not to use this pen. Today it found in use. Tear down pen and isolate bare dirt areas until good carpet of grass is established. Advised Elaine and Jerry of this today. Chain link pen on grass may be used.
