Categories requiring licensure by NCDA&CS Veterinary Division via this application:

1. Hatchery

Definition:

- Any establishment that operates hatchery equipment for the production of baby chicks (poults, goslings, etc.)
- Licensure required only if more than 500 chicks (or poults, etc.) per week are being hatched.

Requirements:

- Every hatchery shall keep such records of operation as the regulations of the Department of Agriculture may require for the proper inspection of said hatchery. The records of operation shall consist of a permanent record showing the name and address of the breeder flock from which all eggs received, together with the number of eggs and date received. A permanent record of all hatching eggs and baby chicks sold must also be maintained. This is to include number birds/eggs in transaction, bird/egg breeder flock(s) of origin, date of transaction, and name and address of purchaser.
- Per § 106-543, "All baby chicks [and] turkey poults... sold or offered for sale shall originate in flocks that meet the requirements of the National Poultry Improvement Plan as administered by the North Carolina Department of Agriculture and Consumer Services..." It is incumbent upon chick dealers to be able to provide proof of such compliance upon request by the NCDA&CS.

2. Chick Dealer

Definition:

- Any person, firm, corporation that buys baby chicks or turkey poults and sells or offers them for sale

Requirements:

- Every chick dealer or jobber shall keep such records of operation as the regulations of the Department of Agriculture may require for the proper inspection of said dealer or jobber. The records of operation shall consist of a permanent record of all purchases and sales that consist of 100 or more birds, each record to include: type of transaction (i.e. purchase or sale), date of transaction, number of chicks and/or number of turkey poults in transaction, and name and address of second party in transaction.
- Per § 106-543, "All baby chicks [and] turkey poults... sold or offered for sale shall originate in flocks that meet the requirements of the National Poultry Improvement Plan as administered by the North Carolina Department of Agriculture and Consumer Services..." It is incumbent upon chick dealers to be able to provide proof of such compliance upon request by the NCDA&CS.

3. Hatching Egg Dealer

Definition:

- Any person, firm or corporation that buys hatching eggs and sells or offers them for sale
- Licensure required only if more than 250 hatching eggs per month are being sold.

Requirements:

- Every hatching egg dealer shall keep such records of operation as the regulations of the Department of Agriculture may require for the proper inspection of said dealer.
- Per § 106-543, "All...hatching eggs sold or offered for sale shall originate in flocks that meet the requirements of the National Poultry Improvement Plan as administered by the North Carolina Department of Agriculture and Consumer Services..." It is incumbent upon hatcheries to be able to provide proof of such compliance upon request by the NCDA&CS.

4. Poultry/Ratite Dealer

Definition:

- Any person who sells or offers for sale to the general public live poultry or ratites. Live poultry or ratite dealer does not include persons who sell on their own premises live poultry or ratites that were raised on the same premises.

Requirements:

- A poultry or ratite dealer shall keep records of all purchases and sales of poultry and ratites, showing the date of each purchase or sale, the number of birds involved in the transaction, and the name and address of the seller or purchaser. A poultry dealer shall also keep records of any disease testing performed on poultry/ratites under his control that are offered for sale. Purchases, sales, and health records must be available for examination upon request by the Department and shall be kept for three years.
